Rather, I am and will remain responsible for the actions of my dog(s) and/or other pet(s) either while under Family Dog Training's instruction or control or while under my own care regardless of whether I am following the Family Dog Training's instructions. I have been told by Family Dog Training and understand the inherent risks in owning dog(s) and/or other pet(s), including but not limited to the risk of bites to me and/or others, any and all damage to property and/or harm to other animals. Behavior is not static; and an animal will not continue to perform even trained behaviors without ongoing practice. Especially in cases involving any type of aggression. Although behavior may be modified, the pet is never considered "cured". A pet's behavior is ultimately the owner's responsibility. Family Dog Training will make every reasonable effort to help Client attain goals but makes no guarantees of performance on the part of Client or the pet(s) as a result of providing professional animal behavior consultation.
